8		annual fee of \$105,000.00, in lieu of revenue sharing and (ii) establish a reserve				
9	5	account in which to collect the revenue it normally receives and use it to offset				
10		the annual fee; and				
11	WHEREAS,	Wells Fargo Bank will continue to provide Minors Per Capita Trust Services				
12		including member recordkeeping, custodial services, investment management,				
13		member education, report distribution, tax reporting and distribution, and				
14		meeting and presentations to the Nation; and				
15	WHEREAS,	the Nation's Investment Committee has reviewed the proposed Amendment to				
16		the Wells Fargo Services Agreement and recommends its approval.

18		Amendment to the Wells Fargo Services Agreement for the Minors' Per Capita
