

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving SAWRSA Purchased Equipment Insurance Budget for fiscal year 2017)

RESOLUTION NO. 16-429

1 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Legislative Council authorized**
2 **San Xavier Cooperative Association to perform maintenance for the completion**
3 **of the bank stabilization of the Santa Cruz River; and**

4 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Nation purchased equipment**
5 **and materials necessary for the project and the Nation assumes financial**
6 **responsibility of the yearly insurance cost on such equipment; and**

7 **WHEREAS, pursuant to Section 309 (a) of the Southern Arizona Water Rights Settlement Act**
8 **of 1982 ("SAWRSA") the Tohono O'odham Nation (the "Nation") received**
9 **\$15,000,000.00 to be held in trust by the Nation (the "SAWRSA Trust Fund"); and**

10 **WHEREAS, under Section 309 (b) of SAWRSA, the Nation may expend accrued interest and**
11 **dividends on the SAWRSA Trust Fund "for the subjugation of land, development**
12 **of water resources, and the construction, operation, maintenance, and the**
13 **replacement of related facilities on the Papago Reservation (now known as the**
14 **Tohono O'odham Reservation) which are not the obligation of the United States**
15 **under this (SAWRSA) or any other Act of Congress"; and**

16 **WHEREAS, the San Xavier Cooperative Association has agreed to pay for the yearly**
17 **maintenance cost of the equipment and request that the Nation pay for the**
18 **yearly insurance cost per resolution No 08-96; and**

19 **WHEREAS, the Equipment Insurance Budget qualify for the funding under the SAWRSA**
20 **Trust Fund; and**

21 **WHEREAS, the San Xavier District has prepared the attached budget for the SAWRSA**
22 **Purchased Equipment Insurance Budget for Fiscal Year 2017 in the amount of**
23 **\$2,311.00 and funded from the SAWRSA Trust Fund; and**

24 **WHEREAS, the Water Resource and Budget and Finance Committees have reviewed and**
25 **recommended approval.**

26 **NOW, THEREFORE, BE IT RESOLVED: The Tohono O'odham Legislative Council hereby**
27 **approves the SAWRSA Purchased Equipment Insurance Budget for Fiscal Year**
28 **2017 in the amount of \$ 2,311.00 from the SAWRSA Trust Fund.**

29 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
30 **District Chairperson and any designated official to expend and administer the**
31 **Budget as attached, provided that any modifications or amendments affecting**

1 the funds or funding level is submitted for further prior approval by the Tohono
2 O'odham Legislative Council.

5 FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the
6 Council by Article VI, Section 1(d)(2) and (f) of the Constitution of the Tohono O'odham Nation,
7 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
8 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
9 16 of the Act of June 18, 1934 (48 Stat.984).


