

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Cultural Affairs Tribal Historic Preservation Office Budget)**

RESOLUTION NO. 16-430

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation ... and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the United States Department of the Interior, National Park Service has awarded**
8 **the Natural Resources Department, Cultural Affairs Tribal Historic Preservation**
9 **Office ("THPO") a grant in the amount of \$82,514.00; and**

10 **WHEREAS, the THPO has prepared and submitted for review and approval its FY 2017**
11 **Cultural Affairs THPO Budget in the amount of \$82,514.00 which is incorporated**
12 **by this reference; and**

13 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have**
14 **reviewed the FY 2017 Cultural Affairs THPO Budget and recommend its**
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2017 Cultural Affairs Tribal Historic Preservation Office Budget effective**
18 **October 1, 2016 in the amount of \$82,514.00 and to utilize the Nation's resources**
19 **pending reimbursement from the grantor.**


20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
21 **O'odham Nation chairperson or any designated official is authorized to**
22 **administer and expend the FY 2017 Cultural Affairs Tribal Historic Preservation**
23 **Office Budget, provided however, that any amendments or modifications shall**
24 **be submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
26 **day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4**
27 **FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**
28 **Council by Article Vi, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**
29 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**




