

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2016-FY 2017 Executive Branch Get Out The Vote Budget)**

**RESOLUTION NO. 16-431**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, to educate, inform, and ultimately increase voter turnout on Election Day, the**  
8 **Office of the Chairman has prepared and submitted for review and approval its**  
9 **FY 2016-FY 2017 Executive Branch Get Out the Vote Budget which is**  
10 **incorporated by this reference, in the amount of \$50,000.00 to be funded from**  
11 **the FY 2016 general fund surplus; and**

12 **WHEREAS, the Rules and Budget and Finance Committees have reviewed the FY 2016-FY**  
13 **2017 Executive Branch Get Out the Vote Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
15 **FY 2016-FY 2017 Executive Branch Get Out the Vote Budget in the amount of**  
16 **\$50,000.00, as per attached budget beginning September 2016 to November 30,**  
17 **2016, which shall be funded by the general fund surplus.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **Chairperson and any designated official to expend and administer the budget as**  
20 **attached, provided that any modifications/amendments affecting the funds or**  
21 **funding level is submitted for prior approval by the Tohono O'odham Legislative**  
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
24 **day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4**  
25 **FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**  
26 **Council by Article Vi, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**  
27 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
28 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
29 **16 of the Act of June 18, 1934 (48 Stat.984).**
