5		or with private persons or organizations on all matters within the authority of the
6		Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and
7	WHEREAS,	the Tohono O'odham Nation ("Nation") has determined that a need exists for it to
8		enter into an agreement with an organization that participates in the Pima
9		County Wireless Integrated Network ("PCWIN") to enable the Nation's Fire
10		Department to use the system, pending approval of its PCWIN participation
11		agreement; and
12	WHEREAS,	the Nation has entered into a Subscriber Services Agreement with the Drexel
13		Heights Fire District, which provides emergency dispatch services to the Fire
14		Department for the San Xavier District; and
15	WHEREAS,	the Drexel Heights Fire District is a participant in the PCWIN and has provided
16		PCWIN radio equipment to the Nation; and
17	WHEREAS,	the agreement shall be in effect for the time period October 1, 2016 to September
18		30, 2017; and
19	WHEREAS,	the Domestic Affairs and the Budget and Finance Committees have reviewed the
20		proposed agreement and recommend approval by the Legislative Council.
21	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
22		Radio Use Agreement with the Drexel Heights Fire District substantially in the
23		form attached hereto and authorizes the Chairman of the Tohono O'odham
24		Nation to execute it and any future amendments solely extending the term of the
25		agreement.
