1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the power "to consult, negotiate and conclude agreements and contracts on
3		behalf of the Tohono O'odham Nation with Federal, State and local governments
4		and other Indian tribes or their departments, agencies, or political subdivisions,
5		or with private persons or organizations on all matters within the authority of the
6		Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and
7	WHEREAS,	the Tohono O'odham Nation ("Nation") entered an Emergency Dispatch Services
8		Agreement with the Drexel Heights Fire District on or about August 16, 2002,
9		which has been extended annually; and
10	WHEREAS,	the Drexel Heights Fire District is now the Managing Administrative Principal of
11		the Valley Emergency Communications Center; and
12	WHEREAS,	under the Subscriber Services Agreement, the Valley Emergency
13		Communications Center will provide emergency dispatch services to the Tohono
14		O'odham Nation Fire Department for the San Xavier District at a cost of \$7,625.00
15		per quarter; and
16	WHEREAS,	the parties have agreed to execute the Subscriber Services Agreement; and
17	WHEREAS,	the Subscriber Services Agreement requires a limited waiver of the sovereign
18		immunity of the Nation in favor of Valley Emergency Communications Center to
19		allow the terms of the Subscriber Services Agreement to be enforced in
20		accordance with its terms; and
21	WHEREAS,	the Domestic Affairs and Budget and Finance Committees have reviewed the
22		terms of the Subscriber Services Agreement, including the limited waiver of
23		sovereign immunity and recommend its approval.
24	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
25		authorizes the following:
26		1. Approval of Subscriber Agreement. The Legislative Council authorizes
27		and approves the Subscriber Services Agreement with Valley Emergency
28		Communications Center in substantially the form attached and
29		authorizes the Nation's Chairman to execute it.
