

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the July 11, 12, 13, 14, 15, 19, 21 and 22, 2016 General Session Minutes)**

LEGISLATIVE ORDER NO. 16-434

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council provide the**
6 **process for recording Legislative Council sessions and preparing summarized**
7 **minutes for review and approval by the Legislative Council and "approved**
8 **minutes shall become the official minutes and the property of the Tohono**
9 **O'odham Nation" (Legislative Rules, Article V); and**

10 **WHEREAS, pursuant to Legislative Rules, Article V, Section 2(C), "[a]ll summarized minutes**
11 **shall include the following: the title of each agenda item, presenter's name, and**
12 **for each legislative action shall include the action's title, the representative**
13 **making the motion and second, action number, and the vote count."; and**

14 **WHEREAS, the Legislative Secretary has presented a draft of the summarized minutes of the**
15 **July 11, 12, 13, 14, 15, 19, 21 and 22, 2016 general session for review and approval**
16 **by the Legislative Council; and**

17 **WHEREAS, the Legislative Council has reviewed the minutes and made necessary**
18 **corrections.**

19 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council approves the**
20 **July 11, 12, 13, 14, 15, 19, 21 and 22, 2016 general session minutes.**

21 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13TH day of**
22 **SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat.984).**
