## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving an FY 2017 Attorney Contract with California Indian Legal Services)

**RESOLUTION NO. 16-440** 

1 WHEREAS. the Constitution of the Tohono O'odham Nation vests the Legislative Council with 2 the power to "employ legal counsel for the protection and advancement of the 3 rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham 4 Nation, Article VI, Section 2(a)); and 5 WHEREAS. the Office of Attorney General continues to require the legal services of the 6 California Indian Legal Services to represent the Tohono O'odham Nation in legal 7 proceedings in California involving the Nation's interests under the Indian Child 8 Welfare Act for the period of October 1, 2016 to September 30, 2017; and 9 WHEREAS. the Domestic Affairs Committee has reviewed the FY 2017 attorney contract with 10 California Indian Legal Services and recommends approval by the Legislative 11 Council. 12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 13 FY 2017 attorney contract with California Indian Legal Services and authorizes 14 the chairperson of the Tohono O'odham Nation to execute it in substantially the 15 form attached. 16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 2,770.8 FOR; -0-17 18 AGAINST; -Q- NOT VOTING; and 250.6 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the 19 20 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant 21 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 22 18, 1934 (48 Stat.984). 23 24 25 ODHAM LEGISLATIVE COUNCIL 26 27 28 29 Legislative Chairman 30 31 32 33 34 ATTES 35 36 37 38 39
