

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an FY 2017 Attorney Contract with the Law Firm of Juan C. Flamand, PLLC)**

RESOLUTION NO. 16-442

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to "employ legal counsel for the protection and advancement of the**
3 **rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of the Law Office of Juan**
6 **C. Flamand, PLLC to provide legal advice and representation to the Tohono**
7 **O'odham Nation's Office of Attorney General in matters relating to Special**
8 **Juvenile Immigration Status filings on behalf of Mexican National O'odham**
9 **children who are wards of the Tohono O'odham Children's Court for the period of**
10 **October 1, 2016 to September 30, 2017; and**

11 **WHEREAS, the Domestic Affairs Committee has reviewed the FY 2017 attorney contract with**
12 **the law office of Juan C. Flamand, PLLC and recommends approval by the**
13 **Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2017 attorney contract with the law office of Juan C. Flamand, PLLC and**
16 **authorizes the chairperson of the Tohono O'odham Nation to execute it in**
17 **substantially the form attached.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH day**
19 **of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat.984).**


