1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education Venito Garcia Library has applied for and received**
8 **the Basic Library Services Grant (Award No. NG-05-16-0107-16) from the Institute**
9 **of Museum and Library Services ("IMLS"), Native American Library Services**
10 **("NALS"), who is the primary library funding agency for the United States**
11 **government, in the amount of \$7,000.00; and**

12 **WHEREAS, the Department of Education Venito Garcia Library has prepared and submitted**
13 **for review and approval its FY 2017 Department of Education Venito Garcia**
14 **Library IMLS Basic Grant Budget in the amount of \$7,000.00; and**

15 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
16 **have reviewed the FY 2017 Department of Education Venito Garcia Library IMLS**
17 **Basic Grant Budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
19 **Institute of Museum and Library Services Basic Library Services Grant and**
20 **approves the FY 2017 Department of Education Venito Garcia Library IMLS Basic**
21 **Grant Budget effective August 1, 2016, in the amount of \$7,000.00.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Nation chairperson or any designated official is authorized to**
24 **administer and expend the FY 2017 Department of Education Venito Garcia**
25 **Library IMLS Basic Grant Budget, provided however, that any amendments or**
26 **modifications shall be submitted for prior approval by the Tohono O'odham**
27 **Legislative Council.**
