14	WHEREAS,	the Enrollment Program has determined that a number of resolutions
15		approving membership and adoption applications misspelled or incorrectly
16		listed the names of members; and
17	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 74-83, 99-
18		039, 99-140, 99-420, 99-475, 99-633, 01-004, 01-589, 02-074, 02-508, 03-493 and 12-
19		260 be amended to reflect the correct name for the members identified in the
20		September 2016 Corrected Enrollment Resolution Summary, which is
21		incorporated by this reference.
