5	WHEREAS,	the Ordinance for the Regulation of Gaming Activities Within the Tohono
6		O'odham Nation (the "Gaming Ordinance") was subsequently amended to
7		authorize per capita distribution payments in accordance with the Initiative
8		(Legislative Council Resolution No. 97-303); and
9	WHEREAS,	the Legislative Council did adopt the Third Revenue Allocation Plan pursuant to
10		Legislative Council Resolution No. 06-307; and
11	WHEREAS,	on July 28, 2006, the Secretary of the Department of Interior approved the Third
12		Revenue Allocation Plan; and
13	WHEREAS,	the Tohono O'odham Nation Department of Membership Services submitted to
14		the Tohono O'odham Legislative Council the Master List for Eligible Adult
15		Tohono O'odham Members for the Third Per Capita Distribution ("Master List")
16		for review and approval; and
17	WHEREAS,	Legislative Council approved the Master List with the initial number of 17,669
18		verified adult members (Resolution Number 06-624); and
19	WHEREAS,	the disbursement of funds to each eligible adult member is contingent upon
20		verification of a member and certification by the Tohono O'odham Legislative
21	*	Council; and
22	WHEREAS,	the Tohono O'odham Department of Membership Services has submitted a
23		certification list of one verified adult member who is listed on the previously
24		approved Master List and is eligible to receive the third per capita payment.
25	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
26		1. Approves the verification and certification of the adult member listed on
27		the attached September 2016 Certification Listing of An Adult Member for
28		the Third Per Capita Distribution.
29		2. Approves the distribution of \$2,000, less any applicable taxes required by
30		federal law, to the adult member listed.
31		3. Authorizes the Chairperson of the Nation or a designated official to
32		execute such other documents as may be necessary to implement this
