

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Baboquivari District Budgets)**

**RESOLUTION NO. 16-458**

1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 16-368**  
2 **"Approving FY 2017 District Allocation and Apportionment of Gaming Revenues**  
3 **to Districts by Equal Distribution"; and**

4 **WHEREAS, the apportionment for the Baboquivari District is in the amount of \$2,178,486.42**  
5 **and is made available for expenditure subject to an approved budget in**  
6 **accordance with Article VI, Section 1(d)(2) and Article IX, Section 7 of the Nation's**  
7 **Constitution; and**

8 **WHEREAS, the Baboquivari District Council did approve the FY2017 Baboquivari District**  
9 **Budgets in the amount of \$2,178,486.42 by Resolution No. 2016-B-60; and**

10 **WHEREAS, Baboquivari District Council, per Resolution 2016-B-61 also approved additional**  
11 **funding to be transferred from Investment Account in the amount of \$38,750.00**  
12 **for a Holiday Bonus and \$10,000.00 for Baboquivari District Day Budget; and**

13 **WHEREAS, Tohono O'odham Legislative Council Resolution 15-260 approved a 2 year budget**  
14 **for the Artesia\Little Tucson Community Building Project which will have a**  
15 **balance of \$128,418.98 of carry forward funds from FY 2016 to be included in the**  
16 **FY 2017 budget; and**

17 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 Baboquivari District**  
18 **Budgets and recommends its approval.**


19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**


1 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>**  
7 **day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
8 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
9 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
10 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
12 **18, 1934 (48 Stat.984).**


