

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Fiscal Year 2017 Gu Achi District Budget in the amount of \$2,178,486.42)**

**RESOLUTION NO. 16-460**

1 **WHEREAS,** the Tohono O'odham Legislative Council enacted Resolution No. 16-368  
2 "Approving FY 2017 District Allocation and Apportionment of Gaming Revenues  
3 to Districts by Equal Distribution"; and

4 **WHEREAS,** the apportionment for the Gu Achi District is in the amount of \$2,178,486.42 and  
5 is made available for expenditure subject to an approved budget in accordance  
6 with Article VI, Section 1(d)(2) and Article IX, Section 7 of the Nation's  
7 Constitution; and

8 **WHEREAS,** the Gu Achi District has prepared and submitted for review and approval its FY  
9 2017 Gu Achi District Budgets in the total amount of \$2,178,486.42 which is  
10 incorporated by this reference; and

11 **WHEREAS,** the Gu Achi District Council approved the Fiscal Year 2017 Budgets for the  
12 District's Administration with Resolution No. 0615-035 which includes the ten (10)  
13 Communities and the District's Senior Services Budget by Resolution No. 0615-  
14 036 for operational and direct services to meet the needs of the District; and

15 **WHEREAS,** the Tohono O'odham Legislative Council Budget and Finance Committee did  
16 review the FY 2017 Gu Achi District Budgets and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council does hereby  
18 approve the Fiscal Year 2017 Gu Achi District Budgets from Gaming Revenues in  
19 the amount of \$2,178,486.42 as attached hereto for the following:
