1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 16-368**
2 **"Approving FY 2017 District Allocation and Apportionment of Gaming Revenues**
3 **to Districts by Equal Distribution"; and**

4 **WHEREAS, the apportionment for the Pisinemo District is in the amount of \$2,178,486.42 and**
5 **is made available for expenditure subject to an approved budget in accordance**
6 **with Article VI, Section 1(d)(2) and Article IX, Section 7 of the Nation's**
7 **Constitution; and**

8 **WHEREAS, the Pisinemo District Council did approve the FY2017 Pisinemo District Budgets**
9 **for Administration and Communities in the amount of \$2,178,486.42 by**
10 **Resolution No. 16-P-27; and**

11 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 Pisinemo District**
12 **Budgets and recommends its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
14 **approves the FY 2017 Pisinemo District Budgets in the amount of \$2,178,486.42**
15 **and authorizes expenditure of funds for the following:**

30 **Council by Article VI, Section 1(d)(2) and Article IX, Section 7 of the Constitution of the Tohono**
31 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**
32 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**
33 **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
