1 **WHEREAS, Tohono O'odham Legislative Council enacted Resolution No. 16-368, "Approving**
2 **FY2017 District Allocation and Appointment of Gaming Revenues to Districts by**
3 **Equal Distribution"; and**

4 **WHEREAS, the apportionment for the Hickiwan District is in the amount of \$2,207,785.60 and**
5 **is made available for expenditure subject to an approved budget in accordance**
6 **with Article VI, Section 1(d)(2) and Article IX, Section 7 of the Nation's**
7 **Constitution; and**

8 **WHEREAS, Hickiwan District Council approved the FY 2017 Budgets for the District**
9 **Administration and its communities by District Resolution No. HDC-16-035; and**

10 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**
11 **attached Budgets and recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves the FY 2017 Hickiwan District budgets in the amount of \$2,207,785.60 of**
14 **Gaming revenues as attached for the following:**



31 **Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
