1 WHEREAS. the Legislative Council is authorized "to manage any funds within the exclusive 2 control of the Tohono O'odham Nation... and to appropriate these funds for the 3 benefit of the Nation and its members" provided that "all expenditures of these 4 funds shall be pursuant to appropriations or budgets" authorized by resolution 5 or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Sections 6 1(d)(2)); and 7 WHEREAS. the current fiscal year will expire on September 30, 2016 and the San Lucy 8 District's authority to expend funds appropriated for fiscal year 2016 will end on 9 this day; and 10 WHEREAS. by Resolution No. SL 08-83-16, the San Lucy District has requested approval of a 11 continuing resolution authorizing expenditures under the District's current 12 budget beyond the end of this fiscal year and until an FY 2017 budget is approved 13 by Legislative Council; and 14 WHEREAS, there are sufficient funds in the San Lucy District account to continue District 15 operations. 16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes 17 the San Lucy District to expend funds in accordance with the District's FY 2016 18 budget after September 30, 2016 and until an FY 2017 budget is approved by 19 Legislative Council resolution. 20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16^{TH} 21 day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 3.021.4 22 FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and [<u>04</u>] ABSENT, pursuant to the powers vested in the 23 Council by Article VI, Section 1(d) and Article IX, Section 7 of the Constitution of the Tohono 24 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved 25 by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, 26 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984). 27 28 HONO O'ODHAM LEGISLATIVE COUNCIL 29 30 31 32 mothy Joaquin/Legislative Chairman 33 34 35 36 37 38 39 **Evonne Wilson, Legislative Secretary** 40 41
