1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 16-368 approved the FY**
2 **2017 District Allocation and Apportionment of Gaming Revenues to Districts by**
3 **Equal Distribution; and**

4 **WHEREAS, the apportionment for the Sells District is in the amount of \$2,178,486.42 and is**
5 **made available for expenditure subject to an approved budget in accordance**
6 **with Article VI, Section 1(d)(2) and Article IX, Section 7 of the Nation's**
7 **Constitution; and**

8 **WHEREAS, Sells District Council did approve the FY 2017 Sells District Administration and**
9 **Community budgets in the amount of \$2,178,486.42 by Resolution No. SD-78-16;**
10 **and**

11 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed this**
12 **budget and recommends its approval.**


13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**

27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

29 **day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4**

31 **Council by Article VI, Section 1(d)(2) and Article IX, Section 7 of the Constitution of the Tohono**
32 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
33 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
