RESOLUTION NO. 16-472

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Tohono O'odham
2		Legislative Council with the power "to manage any funds within the exclusive
3		control of the Tohono O'odham Nation, including proceeds derived from lands
4		and resources of the Tohono O'odham Nation" (Constitution, Article VI, Section
5		1(d)(2)); and
6	WHEREAS,	the Tohono O'odham Nation has investments on account at the United States
7		Department of the Interior Office of Special Trustee for American Indians
8		("OST"); and
9	WHEREAS,	the OST has a current signature card on file identifying the Nation's elected
10		officials who are authorized to conduct business with the OST, but the OST has
11		requested a Nation's resolution identifying elected officials authorized to
12		conduct business with the OST; and
13	WHEREAS,	the Nation's chairperson and vice chairperson are the Nation's designated
14		signatories who are generally authorized to withdraw funds from the Nation's
15		accounts (Resolution No. 190-88 "Reauthorizing Opening Of and Withdrawals
16		from Bank Accounts," as amended by Resolution No. 06-466); and
17	WHEREAS,	Legislative Order No. 15-225 identifies the current chairman of the Nation as
18		Edward D. Manuel and vice chairman of the Nation as Verlon M. Jose; and
19	WHEREAS,	the Financial Investment Policy of the Tohono O'odham Nation, as adopted by
20		Resolution No. 91-042 and amended by Resolution No. 01-213, identifies the
21		composition of the Nation's Investment Committee, the chair of which serves as
22		a designated signatory, and designates the Budget and Finance Committee as
23		the oversight committee for investments.
24	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes
25		the Nation's chairperson, the Nation's vice chairperson, and, in the absence of
26		the Nation's chairperson and vice chairperson, the Investment Committee
27		chair, to conduct business with the Office of Special Trustee for American
28		Indians; provided that the authority to sign checks and other instruments
29		relating to the Nation's finances; to expend funds; to establish, manage, and
30		control bank accounts; to manage investments; and to exercise any other fiscal
31		power shall be subject to the Constitution and laws of the Nation.
