

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Florence KOHF-LP Radio Project Budget Amendment No. 2)**

RESOLUTION NO. 16-477

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2015 Florence KOHF-LP Radio Project Budget in the amount of \$80,695.57**
8 **was approved by Resolution No. 15-237; and**

9 **WHEREAS, the carryover balance of \$32,968.59 from the FY 2015 Florence KOHF-LP Radio**
10 **Project Budget was extended into fiscal year 2016 by Resolution No. 15-399; and**

11 **WHEREAS, the FY 2016 Florence KOHF-LP Radio Project Budget Amendment No. 1, which**
12 **did not change the budget amount of \$32,968.59, was approved by Resolution No.**
13 **15-475; and**

14 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2016**
15 **Florence KOHF-LP Radio Project Budget Amendment No. 2, which is**
16 **incorporated by this reference and which will adjust operational and capital**
17 **line items; and**

18 **WHEREAS, the FY 2016 Florence KOHF-LP Radio Project Budget Amendment No. 2 will not**
19 **change the Florence KOHF-LP Radio Project Budget amount of \$32,968.59; and**

20 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed**
21 **the FY 2016 Florence KOHF-LP Radio Project Budget Amendment No. 2 and**
22 **recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2016 Florence KOHF-LP Radio Project Budget Amendment No. 2 with no**
25 **change to the total budget of \$32,968.59, which was approved by Resolution No.**
26 **15-399 and 15-475.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
28 **O'odham Nation chairperson or any designated official is authorized to**
29 **administer and expend the FY 2016 Florence KOHF-LP Radio Project Budget as**
30 **amended, provided however, that any amendments or modifications shall be**
31 **submitted for prior approval by the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 2.801.5 FOR; -0- AGAINST; -0- NOT VOTING; and 219.9[10] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
