

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Continuing Expenditures in Accordance with FY 2016 Self-Governance Budgets)

RESOLUTION NO. 16-486

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation... and to appropriate these funds for the**
3 **benefit of the Nation and its members" provided that "all expenditures of these**
4 **funds shall be pursuant to appropriations or budgets" authorized by resolution**
5 **or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Sections**
6 **1(d)(2)); and**

7 **WHEREAS, the Legislative Council appropriated funds by Resolution No. 16-275 for the FY**
8 **2016 Department of Health and Human Services, Department of Public Safety,**
9 **and Department of Information and Technology Self-Governance Budgets (with**
10 **EMS Security Dispatch Budget amended by Resolution No. 16-403), and by**
11 **Resolution No. 16-273 for the FY 2016 Office of the Treasurer Supplemental,**
12 **Grants & Contracts Supplemental, Accounting Supplemental, Human Resources**
13 **Supplemental, DoIT Supplemental, Facilities San Simon, Facilities San Xavier,**
14 **Facilities Sells and Planning Facilities & Engineering Budgets, as all identified in**
15 **the "FY 2016 Tohono O'odham Nation Self-Governance Budgets" schedule A,**
16 **which is incorporated by this reference; and**

17 **WHEREAS, the authority to expend appropriated funds within the FY 2016 Tohono O'odham**
18 **Nation Self-Governance Budgets will end on September 30, 2016, the last day of**
19 **the Nation's fiscal year; and**

20 **WHEREAS, the Tohono O'odham Health and Human Service Department and the Legislative**
21 **oversight committees are in the process of finalizing FY 2017 Self-Governance**
22 **budgets and recommend that the Legislative Council authorize continuing**
23 **expenditures under the FY 2016 Self-Governance Budgets beyond the end of FY**
24 **2016 and until FY 2017 Self-Governance budgets are approved by Legislative**
25 **Council resolution; and**

26 **WHEREAS, the Nation's treasurer has confirmed that there are sufficient funds available to**
27 **support expenditures under the FY 2016 Self-Governance Budgets until FY 2017**
28 **Self-Governance budgets are approved by the Legislative Council.**

29 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes**
30 **continued expenditures in accordance with the FY 2016 Self-Governance**
31 **Budgets beyond the end of FY 2016 and until FY 2017 Self-Governance budgets**
32 **are approved by Legislative Council resolution; provided that salaries within the**
33 **FY 2016 Self-Governance Budgets shall be adjusted effective October 1, 2016 to**
34 **reflect the 2.16% cost of living adjustment authorized within the Nation's FY**
35 **2017 budget instructions.**
