

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an FY 2017 Attorney Contract with the Law Firm of Garvey Schubert Barer)**

**RESOLUTION NO. 16-489**

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council  
2 with the power to "employ legal counsel for the protection and advancement of  
3 the rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham  
4 Nation, Article VI, Section 2(a)); and


5 **WHEREAS,** the Office of Attorney General requires the legal services of the law firm of  
6 Garvey Schubert Barer to provide legal advice and representation to the Tohono  
7 O'odham Nation's Office of Attorney General in matters involving the O'odham  
8 Hewel Ni'ok and the Federal Communications Commission for the period of  
9 October 1, 2016 to September 30, 2017; and

10 **WHEREAS,** the Domestic Affairs Committee has reviewed the FY 2017 attorney contract with  
11 the law firm of Garvey Schubert Barer and recommends approval by the  
12 Legislative Council.

13 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
14 FY 2017 attorney contract with the law firm of Garvey Schubert Barer and  
15 authorizes the chairperson of the Tohono O'odham Nation to execute it in  
16 substantially the form attached.

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29<sup>th</sup>**  
18 **day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 2,794.9**  
19 **FOR; -0- AGAINST; -0- NOT VOTING; and 226.5 [06] ABSENT, pursuant to the powers vested in the**  
20 **Council by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted**  
21 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
22 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
23 **Act of June 18, 1934 (48 Stat.984).**
