

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an FY 2017 Attorney Contract with the Law Office of Yoder & Langford, P.C.)**

**RESOLUTION NO. 16-492**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the power to "employ legal counsel for the protection and advancement of**  
3 **the rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**  
4 **Nation, Article VI, Section 2(a)); and**


5 **WHEREAS, the Office of Attorney General requires the legal services of the Law Office of**  
6 **Yoder & Langford, P.C., to provide legal advice and representation to the Tohono**  
7 **O'odham Nation's Office of Attorney General in matters involving Internal**  
8 **Revenue Services audits and investigation of the Districts and Nation, and**  
9 **matters relating to retirement and pension plans; for the period of October 1,**  
10 **2016 to September 30, 2017; and**

11 **WHEREAS, the Domestic Affairs Committee has reviewed the FY 2017 attorney contract with**  
12 **the law office of Yoder & Langford, P.C. and recommends approval by the**  
13 **Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
15 **FY 2017 attorney contract with the law office of Yoder & Langford, P.C. and**  
16 **authorizes the chairperson of the Tohono O'odham Nation to execute it in**  
17 **substantially the form attached.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29<sup>TH</sup>**  
19 **day of SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 2,794.9**  
20 **FOR; -0- AGAINST; -0- NOT VOTING; and 226.5 [05] ABSENT, pursuant to the powers vested in the**  
21 **Council by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted**  
22 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
23 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
24 **Act of June 18, 1934 (48 Stat.984).**




