

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Plan of Operation for the Budget and Finance Committee)**

**LEGISLATIVE ORDER NO. 16-497**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish rules**  
2 **and procedures to regulate all meetings of the Tohono O'odham Legislative**  
3 **Council, standing committees, boards and special committees (Constitution of**  
4 **the Tohono O'odham Nation, Article VI, Section 1(a) and (b)); and**

5 **WHEREAS, the Legislative Council has adopted and amended the Legislative Rules of the**  
6 **Tohono O'odham Legislative Council ("Legislative Rules") to govern the general**  
7 **structure of the Council's standing committees; and**

8 **WHEREAS, Article XI, Section 2(C) of the Legislative Rules provides that "The Rules**  
9 **Committee shall review and make recommendations on proposed legislative**  
10 **committee plans of operation and amendments to plans of operation to the**  
11 **Legislative Council."; and**

12 **WHEREAS, the Legislative Council last amended the plan of operation for the Legislative**  
13 **Council's Budget and Finance Committee on May 15, 2015 by Legislative Order No.**  
14 **15-149; and**

15 **WHEREAS, the Budget and Finance Committee has drafted an addition to Article III.B. of its**  
16 **Plan of Operation to vest the Committee with the authority to approve year-end**  
17 **budget close-out procedures and related variances, and has presented the**  
18 **amendment to the Rules Committee; and**

19 **WHEREAS, the Budget and Finance and Rules Committees recommend that the Council**  
20 **approve the amended Plan of Operation for the Budget and Finance Committee**  
21 **as dated for reference September 2016.**


22 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council adopts the**  
23 **amended Plan of Operation for the Budget and Finance Committee as dated for**  
24 **reference September 2016.**

25 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 29<sup>TH</sup> day of**  
26 **SEPTEMBER, 2016 at a meeting at which a quorum was present with a vote of 2,794.9 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and 226.5[05] ABSENT, pursuant to the powers vested in the Council**  
28 **by Article VI, Section 1(a) and (b) of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat.984).**


