8		eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);

10	WHEREAS,	Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
11		O'odham Legislative Council shall determine whether an application is
12		approved for membership and its determination, along with the resolution
13		number and date of enactment, shall be provided to the applicant; and
14	WHEREAS,	the Enrollment Program has received the official documents showing the legal
15		name changes of enrolled members due to a variety of reasons, such as
16		marriage, divorce, or legal adoption; and
17	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 66-80, 49-
18		81, 41-82, 136-82, 129-83, 184-83, 92-463, 94-154, 97-221, 97-350, 03-301, 06-787,
19		11-158 and 16-279 be amended to reflect the amended names for the members
20		identified in the October 2016 Amended Enrollment Resolution Summary, which
21		is incorporated by this reference.
