

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 99-039, 99-080, 99-140, 99-200, 99-311,
01-416, 2000-223, 02-129, 02-180, 07-075 and 07-500 to Correct Names of
Enrolled Members and/or Enrollment Numbers)**

RESOLUTION NO. 16-502

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members (Article II,
3 Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono
4 O'odham Nation); and

5 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the
6 Enrollment Committee is responsible for reviewing enrollment applications
7 and making recommendations to the Legislative Council regarding the
8 eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);
9 and

10 **WHEREAS,** Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
11 O'odham Legislative Council shall determine whether an application is
12 approved for membership and its determination, along with the resolution
13 number and date of enactment, shall be provided to the applicant; and

14 **WHEREAS,** the Enrollment Program has determined that a number of resolutions
15 approving membership and adoption applications misspelled or incorrectly
16 listed the names of members and/or incorrectly listed enrollment numbers; and

17 **WHEREAS,** the Enrollment Program therefore recommends that Resolution Nos. 99-039, 99-
18 080, 99-140, 99-200, 99-311, 01-416, 2000-223, 02-129, 02-180, 07-075 and 07-500
19 be amended to reflect the correct name and/or enrollment number for the
20 members identified in the October 2016 Corrected Enrollment Resolution
21 Summary, which is incorporated by this reference.

22 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that
23 Resolution Nos. 99-039, 99-080, 99-140, 99-200, 99-311, 01-416, 2000-223, 02-129,
24 02-180, 07-075 and 07-500 are amended upon the effective date of those
25 resolutions to reflect the correct name and/or enrollment number for the
26 members identified in the October 2016 Corrected Enrollment Resolution
27 Summary.

28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH
29 day of OCTOBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;
30 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
31 Article II, Section 1 and Section 2 and Article VI, Section 1(h) of the Constitution of the Tohono
32 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved
33 by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
34 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
