5		or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section
6		1(d)(2)); and
7	WHEREAS,	on December 10, 2004, the United States Congress enacted the Arizona Water
8		Settlements Act, P.L. 108-451, including Title III, the Southern Arizona Water
9		Rights Settlement Act Amendments ("SAWRSA Amendments"), which authorized
10		the San Xavier District to elect to receive \$18.3 million in lieu of the federal
11		government's obligation to construct the proposed "9B Farm" (SAWRSA
12		Amendments, Section 304(c)(3)(A)(ii)); and
13	WHEREAS,	the San Xavier District Council elected to receive the in lieu payment plus
14		interest pursuant to SXDC Resolution #10-09-10 ("9B Farm Cashout Fund"); and
15	WHEREAS,	expenditures from the San Xavier District 9B Farm Cashout Fund must be
16		authorized and approved in accordance with a budget authorized by the District
17		Council and approved by resolution of the Legislative Council (SAWRSA
18		Amendments, Section 304(f)(1)(B)(i) and (ii)); and
19	WHEREAS,	following approval by San Xavier District Council resolution, by Resolution No.
20		15-371, the Legislative Council approved the FY 2016 San Xavier Allottees
21		Association Budget and Expenditure of SAWRSA Amendments 9B Farm Cashout
22		Fund in the amount of \$484,833.00; and
23	WHEREAS,	the 2016 fiscal year expired on September 30, 2016 and the San Xavier Allottees
24		Association's authority to expend funds appropriated for fiscal year 2016 has
25		ended; and
26	WHEREAS,	on September 20, 2016, the San Xavier District Council by Resolution SXDC 09-
27		16-07 approved the San Xavier Allottees Association's request for a continuing
28		resolution to continue SXAA program operations and to operate at the Fiscal
29		Year 2016 budget level; and
30	WHEREAS,	the Budget and Finance Committee has reviewed the San Xavier Allottees
31		Association's request and recommends that the Legislative Council approve the
32		continuing expenditure authority.
