

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Arizona Department of Economic Security Intergovernmental Agreement**  
**Amendment No. 2 and the FY 2017 Department of Education One Stop Division Budget**  
**Amendments No. 1 for PY Dislocated Worker, FY Dislocated Worker, PY Adult/Youth Admin.,**  
**PY Youth, FY Adult Admin., and FY Adult)**

**RESOLUTION NO. 16-518**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation ... and to  
3 appropriate these funds for the benefit of the nation and its members" provided  
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or  
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono  
6 O'odham Nation, Article VI Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to consult, negotiate and  
8 conclude agreements and contracts on behalf of the Tohono O'odham Nation  
9 with Federal, State and local governments and other Indian tribes or their  
10 departments, agencies, or political subdivisions" (Constitution of the Tohono  
11 O'odham Nation Article VI, Section 1(f)); and

12 **WHEREAS,** the Arizona Department of Economic Security Workforce Innovation and  
13 Opportunity Act Intergovernmental Agreement ("IGA") was approved by  
14 Resolution No. 15-441; and

15 **WHEREAS,** the Department of Education One Stop Division FY 2017 PY Dislocated Worker,  
16 FY Dislocated Worker, PY Adult/Youth Admin., PY Youth, FY Adult Admin., PY  
17 Adult, and FY Adult Budgets were approved by Resolution No. 16-242; and

18 **WHEREAS,** the Arizona Department of Economic Security has granted the Tohono O'odham  
19 Nation One Stop Division \$361,261.00 for a period beginning on July 1, 2016  
20 through June 30, 2018 as detailed in Amendment No. 2 to the IGA; and

21 **WHEREAS,** the Department of Education One Stop Division has prepared and submitted for  
22 review its FY 2017 Budget Amendments No. 1 for its PY Dislocated Worker, FY  
23 Dislocated Worker, PY Adult/Youth Admin., PY Youth, FY Adult Admin., PY Adult,  
24 and FY Adult Budgets, which are incorporated by this reference and which will  
25 adjust operational and personnel line items; and

26 **WHEREAS,** Budget Amendment No. 1 will adjust Operations Line items to create line items  
27 7305 General Liability Insurance, Capitol Line items 8060 Alternations and  
28 Renovations, and increasing Operational and Capitol Expense line items; and

29 **WHEREAS,** the FY 2017 Department of Education One Stop Budget Amendments No. 1 will  
30 increase the Department of Education FY 2017 One Stop Budget by \$38,593.00  
31 from \$322,668.00 to \$361,261.00 that shall be funded by the Nation's general  
32 fund pending reimbursement from the grantor by way of Workforce Innovation  
33 & Opportunity Act ("WIOA"), Title IB funds; and

1 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
2 **reviewed the Arizona Department of Economic Security IGA Amendment No. 2**  
3 **and the FY 2017 Department of Education One Stop Division Budget**  
4 **Amendments No. 1 and recommend their approval.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
6 **Arizona Department of Economic Security Intergovernmental Agreement**  
7 **Amendment No. 2 and the FY 2017 Department of Education One Stop Division**  
8 **Budget Amendment No. 1 for the following:**

17 **BE IT FURTHER RESOLVED that this amendment No. 1 will be effective July 1, 2016 through**  
18 **June 30, 2018, which includes a \$38,593.00 increase from \$322,668.00 to**  
19 **\$361,261.00 that shall be funded by the Nation's general fund pending**  
20 **reimbursement from the grantor.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
22 **O'odham Nation chairperson or any designated official is authorized to**  
23 **administer and expend the FY 2017 Department of Education One Stop Division**  
24 **Budgets as amended, provided however, that any amendments or modifications**  
25 **shall be submitted for prior approval by the Tohono O'odham Legislative**  
26 **Council.**


27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>**  
28 **day of OCTOBER, 2016 at a meeting at which a quorum was present with a vote of 3,021,4 FOR;**  
29 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2), 1(c)(2), and 1(f) of the Constitution of the Tohono O'odham Nation,**  
31 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
33 **16 of the Act of June 18, 1934 (48 Stat.984).**


