## LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Setting September 26, 2016 Special Session for an Update from Tohono O'odham Nation Health Care)

LEGISLATIVE ORDER NO. 16-521

1 WHEREAS. the Legislative Council is vested with the power "to establish rules and 2 procedures to regulate all meetings of the Tohono O'odham Council, standing 3 committees, boards and special committees."
