

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Rejecting Membership Application of Angelica S. Salcido)**

**DEFEATED**  
**RESOLUTION NO. 16-527**

1   **WHEREAS,    the Constitution of the Tohono O'odham Nation provides that the membership of**  
2                   **the Nation shall consist of Indians appearing on official census rolls (comprising**  
3                   **the Nation's Base Roll) and "children born to resident members," and vests the**  
4                   **Legislative Council with the power to enact laws and ordinances governing the**  
5                   **enrollment and adoption of members (Constitution, Article II, Section 1(a) and**  
6                   **(b); Article VI, Section 1(h)); and**

7   **WHEREAS,    on February 24, 2015, Angelica S. Salcido filed an application for enrollment as a**  
8                   **member of the Tohono O'odham Nation; and**

9   **WHEREAS,    the Enrollment Committee has reviewed the application and has recommended**  
10                  **that the application be rejected because the applicant failed to establish her**  
11                  **eligibility for membership under the Constitution of the Tohono O'odham**  
12                  **Nation, Article II – Membership, Section 1(b); and**

13   **WHEREAS,    the Enrollment Committee served written notice of its written recommendation**  
14                  **to reject the application and of the rejection hearing upon the applicant as**  
15                  **required by Section 2, Article VI of the Enrollment Ordinance, 14 T.O.C. Chapter 1;**  
16                  **and**

17   **WHEREAS,    the Tohono O'odham Legislative Council has reviewed the enrollment**  
18                  **application, Enrollment Committee's recommendation, and evidence presented**  
19                  **during its October 27, 2016 hearing, at which Angelica S. Salcido was present, and**  
20                  **finds that the applicant has failed to establish the foregoing membership**  
21                  **requirement.**

22   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council finds that the**  
23                  **application of Angelica S. Salcido, date of birth 03/06/1988, for enrollment as a**  
24                  **member of the Tohono O'odham Nation fails to establish her eligibility for**  
25                  **membership under Article II, Section 1(b) of the Constitution of the Tohono**  
26                  **O'odham Nation and the application is rejected.**

27   **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council chairperson shall**  
28                  **provide written notice to the applicant of the Legislative Council's final**  
29                  **determination and the Enrollment Committee shall serve notice of the final**  
30                  **determination in accordance with Section 2, Article VIII of the Enrollment**  
31                  **Ordinance.**
