## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Enrollment Application of Angelica S. Salcido for Membership in the Tohono O'odham Nation)

| 1   | WHEREAS, | the Constitution of the Tohono O'odham Nation provides that the membership of        |

| 7   | WHEREAS, | Article VIII, Section 1(A) of the Nation's Enrollment Ordinance provides in part     |
| 8   |          | that the "Council shall review each application for enrollmenttogether with the      |
| 9   |          | recommendations of the enrollment committee, and determine whether the               |
| 0   |          | applicant is eligible to be enrolled or should be adopted as a member of the         |
| l 1 |          | Nation The Council shall consider all relevant evidence regarding the                |
| 12  |          | applicant's eligibility for enrollment or adoption, but the relevancy, weight and    |
| 13  |          | sufficiency of such evidence shall be determined by the Council." (14 Tohono         |
| 14  |          | O'odham Code Chapter 1); and   |
| 15  | WHEREAS, | on February 24, 2015, an application for enrollment as a member of the Tohono        |
| 16  |          | O'odham Nation was filed for Angelica S. Salcido; and                                |
| 17  | WHEREAS, | the Enrollment Committee has reviewed the application and has recommended            |
| 18  |          | that the application be rejected because the applicant failed to establish her       |
| 19  |          | eligibility for membership under the Constitution of the Tohono O'odham              |
| 20  |          | Nation, Article II – Membership, Section 1(b); and                                   |
| 21  | WHEREAS, | the application of Angelica S. Salcido has come for hearing before the Legislative   |
| 22  |          | Council; and   |
| 23  | WHEREAS, | the Enrollment Committee served written notice of its written recommendation         |
| 24  |          | to reject the application and of the rejection hearing upon the applicant as         |
| 25  |          | required by Section 2, Article VI of the Enrollment Ordinance, 14 T.O.C. Chapter 1;  |
| 26  |          | and  |
| 27  | WHEREAS, | the Tohono O'odham Legislative Council has reviewed the enrollment                   |
| 28  |          | application, Enrollment Committee's recommendation, and evidence presented           |
| 29  |          | during its October 27, 2016 hearing, at which Angelica S. Salcido was present, and   |
| 30  |          | a resolution to reject the application was submitted to a vote of the Council and    |
| 31  |          | failed to pass; and  |
| 32  | WHEREAS, | the rejection hearing procedures provide that if the rejection resolution fails, any |
| 33  |          | Legislative Representative may submit for a vote a written resolution to enroll the  |
| 34  |          | applicant.   |

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council finds that the application of Angelica S. Salcido, date of birth 03/06/1988 for enrollment as a member of the Tohono O'odham Nation, and the evidence and testimony provided at the October 27, 2016 hearing, establishes her eligibility for membership under Article II, Section 1(b) of the Constitution of the Tohono O'odham Nation and the application is approved.

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council chairperson shall provide written notice to the applicant of the Legislative Council's final determination and the Enrollment Committee shall serve notice of the final determination in accordance with Section 2, Article VIII of the Enrollment Ordinance.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> day of OCTOBER, 2016 at a meeting at which a quorum was present with a vote of 1,657.4 FOR; 1,364.0 AGAINST; -0-NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article II, Section 1(b) and Article VI, Section 1(h)of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
