

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognizing the San Lucy District Council Appointment of Lorraine Eiler
as Legislative Council Alternate to Legislative Council
Representative Diana Manuel)

LEGISLATIVE ORDER NO. 16-531

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council**
2 **to "enact laws and ordinances for conducting and regulating elections" and**
3 **provide that the "decision of the Tohono O'odham Council in all election matters,**
4 **including the eligibility and qualifications of candidates, shall be final"**
5 **(Constitution, Article VI, Section 1(g) and Article X, Section 7); and**

6 **WHEREAS, the Legislative Council alternate seat to San Lucy District Representative Diana**
7 **Manuel has remained vacant; and**

8 **WHEREAS, pursuant to 12 Tohono O'odham Code Chapter 1, Section 1505(B)(3), when a**
9 **Legislative Council alternate's seat is vacant, a district may "adopt a resolution**
10 **appointing an alternate who shall hold office for the unexpired term of his**
11 **predecessor; provided that the alternate shall not be seated until the Board**
12 **certifies in writing that the alternate meets all the qualifications for that office";**
13 **and**

14 **WHEREAS, on September 13, 2016, the Election Board certified in writing that Lorraine Eiler**
15 **meets all the qualifications for the office of Legislative Council alternate; and**

16 **WHEREAS, the Legislative Council, as a means of ensuring the orderly transition of public**
17 **office, has recognized by legislative order district council appointments to**
18 **vacancies that are made in accordance with 12 Tohono O'odham Code Chapter 1.**

19 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**
20 **recognizes the San Lucy District Council appointment of Lorraine Eiler to serve as**
21 **alternate to Legislative Council Representative Diana Manuel, who shall serve in**
22 **accordance with the Constitution and laws of the Tohono O'odham Nation and the**
23 **with rules and procedures of the Legislative Council when Representative Diana**
24 **Manuel is unable to attend a Legislative Council session.**

25 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 28TH day of**
26 **OCTOBER, 2016 at a meeting at which a quorum was present with a vote of 2,815.6 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and 205.8[03] ABSENT, pursuant to the powers vested in the Council**
28 **by Article VI, Section 1(g) and Article X, Section 7 of the Constitution of the Tohono O'odham**
29 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**


