

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Professional Services Contract between the Tohono  
O'odham Nation and Michael Brown, Esq.)**

**RESOLUTION NO. 16-533**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**  
2 **the power "to employ legal counsel for the protection and advancement of the**  
3 **Tohono O'odham Nation..." (Constitution, Article VI, Section 2(a)); and**

4 **WHEREAS, the increasing needs of tribal members for legal representation in civil and**  
5 **criminal matters has caused a need for attorneys to handle cases where the**  
6 **Tohono O'odham Advocate Program is ethically conflicted out of the**  
7 **representation; and**

8 **WHEREAS, the Tohono O'odham Advocate Program has prepared and submitted for review a**  
9 **contract with Michael Brown to represent clients who cannot be represented by**  
10 **the Nation's Advocate Program due to a conflict of interest; and**

11 **WHEREAS, the Domestic Affairs Committee has reviewed the contract and recommends**  
12 **approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
14 **Professional Services Contract between the Tohono O'odham Nation and Michael**  
15 **Brown, Esq., and the Tohono O'odham Nation Chairperson is authorized to**  
16 **execute it in substantially the form attached.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>**  
18 **day of NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
19 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
20 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat.984).**




