

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Enrollment or Adoption Applications for Membership in the Tohono  
O'odham Nation for November 2016)**

**RESOLUTION NO. 16-536**

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests**  
2 **the Tohono O'odham Legislative Council with the power to "enact laws and**  
3 **ordinances for governing the enrollment and adoption of members and the**  
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation Enrollment Ordinance,**  
6 **Ordinance No. 05-81 as amended, the Enrollment Committee has reviewed and**  
7 **recommended approval of the Enrollment or adoption applications for the**  
8 **individuals identified in the November 2016 Membership Applications List,**  
9 **which is incorporated by this reference; and**

10 **WHEREAS, pursuant to Article VIII, Section 1(C)(1) and (2) of the Enrollment Ordinance,**  
11 **The final determination as to whether an application for enrollment or**  
12 **adoption is approved or rejected by the Tohono O'odham Council shall**  
13 **be reduced to writing and signed by the Chairman of the Tohono**  
14 **O'odham Council regarding each application for enrollment or**  
15 **adoption filed with the enrollment Committee. Such determinations**  
16 **shall set forth the following findings of fact.**

17 **(1) If on an application for adoption, the date of applicant's birth and,**  
18 **the degree of Papago-Tohono O'odham Indian blood ascribed to the**  
19 **applicant.**

20 **(2) If on an application for enrollment, the date of applicant's birth, the**  
21 **membership requirement or requirements which the Tohono**  
22 **O'odham Council found the applicant did or failed to establish.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has**  
24 **reviewed the Enrollment Committee's recommendations and approves the**  
25 **applications for enrollment or adoption that are identified in the November**  
26 **2016 Membership Applications List which includes the name, date of birth,**  
27 **enrollment number, and membership requirement or, for adoption, the degree**  
28 **of Papago-Tohono O'odham Indian blood for each applicant.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
30 **day of NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4**  
31 **FOR; ~~0~~ AGAINST; ~~0~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**  
32 **Council by Article II, Section 1(a) or (b) and Section 2 and Article VI, Section 1(h) of the**  
33 **Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on**  
34 **January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
35 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**




