**RESOLUTION NO. 16-538**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications and**  
7 **making recommendations to the Legislative Council regarding the eligibility of**  
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**  
10 **O'odham Legislative Council shall determine whether an application is approved**  
11 **for membership and its determination, along with the resolution number and**  
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has received the official documents showing the legal**  
14 **name changes of enrolled members due to a variety of reasons, such as marriage,**  
15 **divorce, or legal adoption; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 46-80, 127-**  
17 **83, 27-84, 95-484, 97-144, 01-004, 01-355, 02-369, 02-508, 05-148, 10-020, 14-081,**  
18 **and 14-254 be amended to reflect the amended names for the members identified**  
19 **in the November 2016 Amended Enrollment Resolution Summary, which is**  
20 **incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
22 **Nos. 46-80, 127-83, 27-84, 95-484, 97-144, 01-004, 01-355, 02-369, 02-508, 05-148,**  
23 **10-020, 14-081, and 14-254 are amended upon the effective date of those**  
24 **resolutions to reflect the legal name changes for the members identified in the**  
25 **November 2016 Amended Enrollment Resolution Summary.**
