

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 15-399 to Extend the Budget Authority into FY 2017  
for the Florence KOHF-LP Radio Project)**

**RESOLUTION NO. 16-541**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the original FY 2015 Florence KOHF-LP Radio Project Budget in the amount of**  
8 **\$80,695.57 was approved by Resolution No. 15-237; and**

9 **WHEREAS, the carryover balance of \$32,968.59 from the FY 2015 Florence KOHF-LP Radio**  
10 **Project Budget was extended into fiscal year 2016 by Resolution No. 15-399; and**

11 **WHEREAS, the FY 2016 Florence KOHF-LP Radio Project Budget Amendment No. 1, which did**  
12 **not change the budget amount of \$32,968.59, was approved by Resolution No. 15-**  
13 **475; and**

14 **WHEREAS, the FY 2016 Florence KOHF-LP Radio Project Budget Amendment No. 2, which**  
15 **also did not change the budget amount of \$32,968.59, was approved by Resolution**  
16 **No. 16-477; and**

17 **WHEREAS, the budget authority under Resolution No. 15-399 expired at the end of FY 2016**  
18 **(September 30, 2016) which makes it necessary to extend such budget authority**  
19 **into FY 2017 to complete the Florence KOHF-LP Radio Project within the**  
20 **construction period, which ends on March 10, 2017; and**

21 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed**  
22 **this resolution and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends**  
24 **Resolution No. 15-399 to extend the budget authority into FY 2017.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation chairperson or any designated official is authorized to administer and**  
27 **expend these funds for the period of October 1, 2016 through September 30, 2017,**  
28 **and the Accounting Department is authorized to post the unexpended balances**

of NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-  
AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by  
the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat.984).




