

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2017 Department of Public Safety, Tohono O'odham
Police Department West Valley Resort Budget Amendment No. 1)**

RESOLUTION NO. 16-544

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Public Safety, Tohono O'odham Police Department**
8 **West Valley Resort Budget in the amount of \$2,183,485.16 was approved by**
9 **Resolution No. 16-322; and**

10 **WHEREAS, the Department of Public Safety, Tohono O'odham Nation Police Department has**
11 **prepared and submitted for review and approval its FY 2017 Budget Amendment**
12 **No. 1, which is incorporated by this reference and which will adjust operational**
13 **and/or personnel line items; and**

14 **WHEREAS, the FY 2017 Department of Public Safety, Tohono O'odham Police Department**
15 **West Valley Resort Budget Amendment No. 1 does not change the total budgeted**
16 **amount; and**

17 **WHEREAS, the Domestic Affairs Committee and Budget and Finance Committee have**
18 **reviewed the FY 2017 Department of Public Safety, Tohono O'odham Police**
19 **Department West Valley Resort Budget Amendment No. 1 and recommend its**
20 **approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2017 Department of Public Safety, Tohono O'odham Police Department West**
23 **Valley Resort Budget Amendment No. 1 effective October 1, 2016 in the amount of**
24 **\$2,183,485.16.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2017 Department of Public Safety, Tohono O'odham Police**
28 **Department West Valley Resort Budget as amended, provided however, that any**



1 amendments or modifications shall be submitted for prior approval by the
2 Tohono O'odham Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH day
4 of NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0-
5 AGAINST; -0- NOT VOTING; and 219.9 [07] ABSENT, pursuant to the powers vested in the Council
6 by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted
7 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
8 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
9 Act of June 18, 1934 (48 Stat.984).


