

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Department of Health and Human Services Healthy
O'odham Promotion Program Budget Amendment No. 1)

RESOLUTION NO. 16-546

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(3)); and**

7 **WHEREAS, the FY 2016 Department of Health and Human Services Healthy O'odham**
8 **Promotion Program Budget in the amount of \$2,241,130.00 was approved by**
9 **Resolution No. 16-084; and**

10 **WHEREAS, the Department of Health and Human Services Healthy O'odham Promotion**
11 **Program has prepared and submitted for review and approval its FY 2016 Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational and personnel line items; and**

14 **WHEREAS, the FY 2016 Department of Health and Human Services Healthy O'odham**
15 **Promotion Budget Amendment No. 1 will not change the budgeted amount of**
16 **\$2,241,130.00; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2016 Department of Health and Human Services Healthy**
19 **O'odham Promotion Program Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2016 Department of Health and Human Services Healthy O'odham Promotion**
22 **Program Budget Amendment No. 1, which will not change the budget amount of**
23 **\$2,241,130.00, and which shall include line item 6004 Christmas Bonus.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2016 Health and Human Services Healthy O'odham Promotion**
27 **Program Budget as amended, provided however, that any amendments or**
