

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Holding November 17, 2016 General Session at the Phoenix Sheraton Airport  
Hotel for the Arizona Indian Gaming Association Emergency Meeting)**

**LEGISLATIVE ORDER NO. 16-551**

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and  
2 procedures to regulate all meetings of the Tohono O'odham Council, standing  
3 committees, boards and special committees." (Constitution of the Tohono  
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative  
6 Council, as amended, provides that "[a]ll Legislative Council sessions shall be  
7 held at the Tohono O'odham Legislative Council chambers located in Sells,  
8 Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the  
9 legislative representatives may vote to hold a session in some location other than  
10 the chambers located at Sells."; and

11 **WHEREAS,** the Commerce Committee has requested the Legislative Council hold its  
12 November 17, 2016 general session at the Phoenix Sheraton Airport Hotel for the  
13 Arizona Indian Gaming Association emergency meeting with roll call beginning  
14 at 9:45 a.m.

15 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that the  
16 November 17, 2016 general session shall be held at the Phoenix Sheraton Airport  
17 Hotel for the Arizona Indian Gaming Association emergency meeting with roll call  
18 beginning at 9:45 a.m.

19 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> day of  
20 NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of ~~3,021.4~~ FOR; ~~0~~  
21 AGAINST; ~~0~~ NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
22 Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the  
23 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
25 18, 1934 (48 Stat.984).


