

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Sells District Administration Budget Amendment #1)**

RESOLUTION NO. 16-553

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation, "No district council shall expend district funds except pursuant to
3 budgets authorized under resolutions of the district council and approved by
4 the Tohono O'odham Council. The management of these funds shall be only by a
5 treasurer or other authorized officer of the district council who has furnished a
6 surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all
7 expenditures of these funds shall be by checks signed by such treasurer or other
8 authorized officer and the chairman or vice chairman of the district council";
9 and

10 **WHEREAS,** Tohono O'odham Legislative Council did pass Resolution No. 16-470 approving
11 the budgets submitted for FY 2017 for Sells District Administration and it's
12 communities; and

13 **WHEREAS,** amendment #1 will create line item 6240 Employer Matching 401k which was not
14 included in the original budget; and

15 **WHEREAS,** Sells District Administration has prepared and acquired approval of the
16 attached budget amendment #1 and it's justifications with Sells District Council
17 Resolution No. SD-87-16, and

18 **WHEREAS,** the Budget and Finance Committee has reviewed FY 2017 Sells District
19 Administration Budget Amendment #1 and recommends its approval.


20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves FY
21 2017 Sells District Administration Budget Amendment #1 moving around a total
22 amount of \$36,859.88, as attached.

23 **BE IT FURTHER RESOLVED** that this amendment does not affect the approved overall Sells
24 District FY 2017 budgeted amount of \$2,178,486.42.


25 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the
26 Sells District Chairperson and any designated District Official to expend and
27 administer the budget as attached, provided that any modifications or
28 amendments affecting the funds or funding levels of the budget shall be
29 submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH day of NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
