

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Office of the Prosecutor Budget Amendment No. 1)**

**RESOLUTION NO. 16-554**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Office of the Prosecutor Budget in the amount of \$940,385.62 was**  
8 **approved by Resolution No. 16-322; and**

9 **WHEREAS, the Office of the Prosecutor has prepared and submitted for review and**  
10 **approval its FY 2017 Budget Amendment No. 1, which is incorporated by**  
11 **reference, and which will adjust operational line items; and**

12 **WHEREAS, the FY 2017 Office of the Prosecutor Budget Amendment No. 1 does not affect the**  
13 **total base budget approved for FY 2017; and**

14 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**  
15 **2017 Office of the Prosecutor Budget Amendment No. 1 and recommend its**  
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2017 Office of the Prosecutor Budget Amendment No. 1.**


19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
20 **O'odham Nation chairperson or any designated official is authorized to**  
21 **administer and expend the FY 2017 Office of the Prosecutor Budget as amended,**  
22 **provided however, that any amendments or modifications shall be submitted to**  
23 **the Tohono O'odham Legislative Council for prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>**  
25 **day of NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
26 **-0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
30 **June 18, 1934 (48 Stat.984).**




