

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Office of Attorney General SAWRSA Budget Amendment No. 1)**

**RESOLUTION NO. 16-556**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Office of Attorney General SAWRSA Budget in the amount of**  
8 **\$300,000.00 was approved by Resolution No. 16-358; and**

9 **WHEREAS, the Office of Attorney General has prepared and submitted for review and**  
10 **approval its FY 2017 SAWRSA Budget Amendment No. 1, which is attached by this**  
11 **reference and adjusts operational line items; and**

12 **WHEREAS, the FY 2017 Office of Attorney General SAWRSA Budget Amendment No. 1 will**  
13 **increase the Office of Attorney General FY 2017 SAWRSA Budget by \$450,000.00**  
14 **from \$300,000.00 to \$750,000.00; and**

15 **WHEREAS, the Domestic Affairs, Water Resources, and Budget and Finance Committees**  
16 **have reviewed the FY 2017 Office of Attorney General SAWRSA Budget**  
17 **Amendment No. 1 and recommend its approval.**


18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2017 Office of Attorney General SAWRSA Budget Amendment No. 1 effective**  
20 **October 1, 2016, which includes a \$450,000.00 increase from \$300,000.00 to**  
21 **\$750,000.00 that shall be funded from the SAWRSA trust fund.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
23 **O'odham Nation chairperson or any designated official is authorized to**  
24 **administer and expend the FY 2017 Office of Attorney General SAWRSA Budget as**  
25 **amended, provided however, that any amendments or modifications shall be**  
26 **submitted for prior approval by the Tohono O'odham Legislative Council.**


27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>**  
28 **day of NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
29 **-0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(c)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
33 **June 18, 1934 (48 Stat.984).**
