

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an FY 2017 Attorney Contract with the Law Firm of Wilmer Cutler
Pickering Hale and Dorr, LLP)**

RESOLUTION NO. 16-558

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power to "employ legal counsel for the protection and advancement of**
3 **the rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of**
6 **Wilmer Cutler Pickering Hale and Dorr, LLP to represent the Tohono O'odham**
7 **Nation in matters relating to the West Valley Resort project for the period of**
8 **October 1, 2016 to September 30, 2017; and**

9 **WHEREAS, the Domestic Affairs Committee has reviewed the FY 2017 attorney contract with**
10 **the law firm of Wilmer Cutler Pickering Hale and Dorr, LLP and recommends**
11 **approval by the Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves**
13 **the FY 2017 attorney contract with the law firm of Wilmer Cutler Pickering Hale**
14 **and Dorr, LLP and authorizes the chairperson of the Tohono O'odham Nation to**
15 **execute it in substantially the form attached.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
17 **day of NOVEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
18 **-0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
19 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
22 **June 18, 1934 (48 Stat.984).**
