15	WHEREAS,	the Gu Achi District Council approved Resolution #1116-170 for a budget in the

17		incorporated by this reference; and
18	WHEREAS,	the Budget and Finance Committee did review the Fiscal Year 2017 Tower User
19		Fees budget and recommend its approval.
