

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Legislative Branch Budget Amendment No. 1)

RESOLUTION NO. 16-573

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these**
4 **funds shall be pursuant to appropriations or budgets" authorized by resolution**
5 **or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section**
6 **1(d)(2)); and**

7 **WHEREAS, the Legislative Branch FY 2017 budget was approved by Resolution No. 16-324;**
8 **and**

9 **WHEREAS, the Legislative Branch administration has prepared and submitted for review**
10 **and approval of its FY 2017 Budget Amendment No 1., which is incorporated by**
11 **this reference and which (1) reduces expenses in 6530 Transportation, 7005**
12 **Supplies – Office Equipment, 7340 Public Relations, 7430 RM Grounds, 7440 RM**
13 **Computer; and (2) increases line items 6020 Overtime Wages, 6110 FICA, 7355**
14 **Professional Services, 8060 Alteration and Renovations; and**

15 **WHEREAS, FY 2017 Legislative Branch Budget Amendment No. 1 will not increase the**
16 **original appropriation to Legislative Branch FY 2017 Budget; and**


17 **WHEREAS, the FY 2017 Legislative Branch Budget Amendment No. 1 has been reviewed and**
18 **recommends approval by the Budget and Finance Committee.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2017 Legislative Branch Budget Amendment No. 1 effective on the date of this**
21 **resolution. As attached hereto.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council Chairperson and Vice-**
23 **Chairperson are authorized to administer the FY 2017 Legislative Branch**
24 **Budget as amended, provided however, that any amendments affecting these**
25 **funds or funding levels budgeted shall be submitted for prior approval by the**
26 **Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of DECEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




