

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 16-379 to Extend the Budget Authority into FY 2017 for
the Hewel Ni'ok Dedicated Revenue Budget)**

RESOLUTION NO. 16-574

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2016 Hewel Ni'ok Dedicated Revenue Budget in the amount of \$4,630.69**
8 **was approved by Resolution No. 16-379; and**

9 **WHEREAS, the budget authority under Resolution No. 16-379 expired on September 30,**
10 **2016, which makes it necessary to extend the budget authority into FY 2017 to**
11 **expend available revenue; and**

12 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed**
13 **this resolution and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends**
15 **Resolution No. 16-379 to extend the budget authority into FY 2017.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
17 **O'odham Nation chairperson or any designated official is authorized to**
18 **administer and expend these funds for the period of October 1, 2016 through**
19 **September 30, 2017, and the Accounting Department is authorized to post the**
20 **unexpended balances of the appropriation as of September 30, 2016 as a carry**
21 **forward into fiscal year 2017 beginning October 1, 2016, provided however, that**
22 **any amendments or modifications shall be submitted for prior approval by the**
23 **Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
25 **day of DECEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
26 **-0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
30 **June 18, 1934 (48 Stat.984).**






