

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Agreement of Sale for Fire Apparatus between the Tohono O'odham
Nation and Kovatch Mobile Equipment Corporation)

RESOLUTION NO. 16-575

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vest the Legislative Council with**
2 **power "to consult, negotiate and conclude agreements and contracts on behalf**
3 **the Tohono O'odham Nation with Federal, State and local governments and**
4 **other Indian Tribes or their departments, agencies, or political subdivisions, or**
5 **with private persons or organization on all matters within the authority of the**
6 **Tohono O'odham Council" (Constitution of the Tohono O'odham Nation, Article**
7 **VI, Section 1(f)); and**

8 **WHEREAS, the Tohono O'odham Nation, Department of Public Safety, Fire Department has**
9 **deemed it necessary to replace its fleet of fire apparatus as it ages and**
10 **maintenance demands increase; and**

11 **WHEREAS, the Tohono O'odham Legislative Council has appropriated recurring capital**
12 **funding for fire apparatus in the Fire Department's general budgets through**
13 **Fiscal Year 2017; and**

14 **WHEREAS, the Kovatch Mobile Equipment Corporation has been selected to build a custom**
15 **pumper for the Tohono O'odham Nation through a competitive bid process; and**

16 **WHEREAS, Domestic Affairs and Budget and Finance Committees have reviewed the**
17 **Agreement and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **Agreement of Sale for Fire Apparatus and authorizes the Nation Chairman to**
20 **execute the Agreement in the substantially the form attached.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
22 **day of DECEMBER, 2016 at a meeting at which a quorum was present with a vote of 2,789.8 FOR;**
23 **-0- AGAINST; 231.6[02] NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the**
24 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
25 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
26 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
27 **Act of June 18, 1934 (48 Stat.984).**
