NOW. THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:

- (1) Approves the FY 2017 City of Tucson High Intensity Drug Trafficking Area Grant Agreement No. HT-16-2617 effective January 1, 2016 thru December 31, 2017 in the amount of \$13,300.00 with a grant period of October 1, 2016 to September 30, 2017, which shall be funded by the Nation's general fund pending reimbursement from the grantor.
- (2) Approves the FY 2017 Department of Public Safety HIDTA-NATIVE Budget.
- (3) Authorizes the Tohono O'odham Nation Police Department to expend the funds from the FY 2017 HIDTA-NATIVE Budget for the period of October 1, 2016 through September 30, 2017 on a reimbursement basis and to utilize the Nation's general fund pending reimbursement from the Grantor for the continuation of this grant.

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Tohono O'odham Nation chairperson or any designated official to administer and expend the FY 2017 Department of Public Safety HIDTA-NATIVE Budget, provided however, that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of DECEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2).(d)(3)and(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
