

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Water Resources Department, BOR SAWRSA Budget)

RESOLUTION NO. 16-577

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Water Resources Department has prepared and submitted for review and**
8 **approval its FY 2017 Water Resources Department, Bureau of Reclamation**
9 **("BOR") Southern Arizona Water Rights Settlement Act ("SAWRSA") Budget,**
10 **which is incorporated by this reference, in the amount of \$412,200.00 to be**
11 **funded from a contract between the Tohono O'odham Nation and the BOR; and**

12 **WHEREAS, the FY 2017 Water Resources Department, BOR SAWRSA Budget provides for a**
13 **Water Management Plan and Groundwater Monitoring Program for the Schuk**
14 **Toak District under the SAWRSA amendments; and**


15 **WHEREAS, Water Resources and Budget and Finance Committees have reviewed the FY**
16 **2017 Water Resources Department, BOR SAWRSA Budget and recommend its**
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2017 Water Resources Department, BOR SAWRSA Budget effective October 1,**
20 **2016, in the amount of \$412,200.00 which shall be funded from a contract**
21 **between the Tohono O'odham Nation and the BOR.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Nation chairperson or any designated official is authorized to**
24 **administer and expend the FY 2017 Water Resources Department, BOR SAWRSA**
25 **Budget as amended, provided however, that any amendments or modifications**
26 **shall be submitted for prior approval by the Tohono O'odham Legislative**
27 **Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH day of DECEMBER, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).






