

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Planning and Economic Development Department Real Property
Management Program Budget)

RESOLUTION NO. 16-578

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Planning and Economic Development Department Real Property**
8 **Management Program has prepared and submitted for review and approval its**
9 **FY 2017 Real Property Management Program Budget, which is incorporated by**
10 **this reference, in the amount of \$480,000.00 to be funded from the Tohono**
11 **O'odham Nation's Lease Revenue Account; and**

12 **WHEREAS, Commerce and Budget and Finance Committees have reviewed the FY 2017**
13 **Planning and Economic Development Department Real Property Management**
14 **Program Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2017 Planning and Economic Development Department Real Property**
17 **Management Program Budget effective October 1, 2016 in the amount of**
18 **\$480,000.00, which shall be funded by the Tohono O'odham Nation's Lease**
19 **Revenue Account.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
21 **O'odham Nation chairperson or any designated official is authorized to**
22 **administer and expend the FY 2017 Planning and Economic Development Real**
23 **Property Department Management Program Budget, provided that any**
24 **amendments or modifications shall be submitted for prior approval by the**
25 **Tohono O'odham Legislative Council.**


